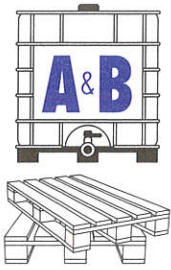
**Please read this privacy policy carefully.**

<b>Data Protection Laws</b>	any applicable law relating to the processing of personal Data, including but not limited to the GDPR, and any national implementing and supplementary laws, regulations, and secondary legislation;
<b>GDPR</b>	the UK General Data Protection Regulation;
<b>A&amp;B Containers Ltd, we or us</b>	A&B Containers Ltd, a company incorporated in England and Wales with registered number 2242483 whose registered office is at 8 Elevator Road, Trafford Park, Manchester, M17 1BR;
<b>User or you</b>	any third party that accesses the Website and is not either (i) employed by A&B Containers Ltd and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to A&B Containers Ltd and accessing the Website in connection with the provision of such services; and

## Scope of this privacy policy

## Data collected

  - f. operating system (automatically collected).

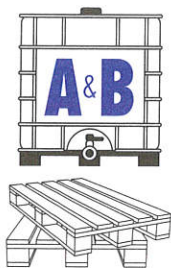

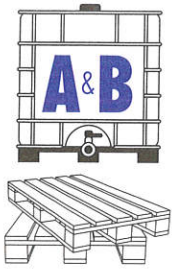
## Our use of Data

## Keeping Data secure

12. We will use technical and organizational measures to safeguard your Data, for example:
  - a. access to your account is controlled by a password and a username that is unique to you.
  - b. we store your Data on secure servers.
  - c. payment details are encrypted using SSL technology (typically you will see a lock icon or green address bar (or both) in your browser when we use this technology).
13. We are certified to ISO 9001. This family of standards helps us manage your Data and keep it secure.

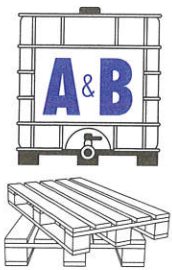

## Data retention

## Your rights

18. You have the following rights in relation to your Data:

If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
  - b. **Right to correct** - the right to have your Data rectified if it is inaccurate or incomplete.
  - c. **Right to erase** - the right to request that we delete or remove your Data from our systems.
  - d. **Right to restrict our use of your Data** - the right to "block" us from using your Data or limit the way in which we can use it.
  - e. **Right to data portability** - the right to request that we move, copy or transfer your Data.
  - f. **Right to object** - the right to object to our use of your Data including where we use it for our legitimate interests.

## Changes of business ownership and control

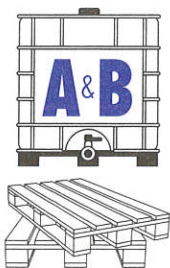

28. Unless otherwise agreed, no delay, act, or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.
29. This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
